Students eligible for Victorian Skills First Funded Training in 2019 will not be charged any Tuition Fees (in line with the Free TAFE Priority Courses initiative). Total Fees displayed include any resources and materials or enrolment fees required for each course.

Notes:

The Victorian Skills First (VSF) program provides subsidies for training to eligible individuals. This training is delivered with Victorian and Commonwealth Government funding. Individuals with disabilities are encouraged to access training subsidised through the Skills First Program. VSF program is available to eligible individuals undertaking training with a physical presence in Victoria. Please see our Funding Eligibility information to determine whether you may be eligible.

FFS refers to a Fee for Service enrolment in which a student is not accessing a subsidised training place such as that offered under the Victorian Skills First program (VSF) or funding programs that may be offered in jurisdictions other than Victoria. Where a student is not able to pay the full fees within two weeks of course commencement, a payment plan will be implemented.

If your course is being subsidised by the Victorian and Commonwealth Governments under the Skills First program, please be aware that enrolling in the above course may affect your future training options and eligibility for further government subsidised training under the Skills First program. Prior to enrolment, all applicants will undertake a Pre-Training Review administered by the RTO to determine course suitability.

The Enrolment Fee (1) comprises the administrative Student Services and Amenities Fee and is payable upon registration. This fee is refundable if cancellation occurs prior to commencement of training. See our Refund policy available on our website for more information and conditions.

The nominal hours as displayed are indicative only and are aligned with the Phillips Institute standard packaging for these qualifications as at the effective date displayed on page 1. They do not represent contact hours, but are indicative of the aggregate hours of study, including all training and assessment activities. As a guide, contact hours vary from 200 to 500, depending on the course requirements, course content and mode of delivery. These contact hours do not include self-directed study or placement hours if applicable.

This course may require, subject to confirmation of elective units, the demonstration of a minimum of 100 hours VET facilitation practice and assessment of a minimum of 20 individuals for at least 50 separate unit assessments and therefore requires access to a suitable training and assessment environment/role. In addition, core unit assessment requirements include opportunity to undertake an organisational training needs analysis and to evaluate a training program. Please consider your ability to meet these requirements before enrolling into this course.

All fees are quoted in Australian dollars. All tuition fees as published are subject to periodic review. Student contribution amounts may be subject to change if there are changes to the VSF subsidy as determined by the Victorian Department of Education and Training, however, such changes will not affect currently enrolled students or those who have applied or registered for enrolment prior to such changes being published.

Student tuition fees as published are subject to change given individual circumstances at enrolment. Student contributions per hour may be rounded down to the nearest cent for administration purposes.
